CONSENT TO TREATMENT (Minor or Competent):

We the undersigned guardians or parents of _____,
do hereby consent to any emergency medical treatment needed in our absence, if we cannot be reach for consent.

Conditions:

- *A four hour minimum, or agreed upon number of hours are required.
- *Reservations cancelled within 24 hours of scheduled arrival of the sitter are subject to the minimum charge and will be billed to your credit card, MasterCard, Visa or Discover.
- *Charges for childcare services are payable each day upon completion of that days work. \$10 an hour (\$8 in the summer) will be charged to the credit card on file and the balance is due the sitter in cash.
- *Rates are \$22 and hour for 1 child, \$24 for 2 children, \$26 for 3 children and \$28 for 4 children (more than 4 children rates arranged through The Clubhouse and may require an additional sitter), holiday rates are higher. Rates subject to change. Rates do not include gratuities.
- *Childcare providers are not authorized to transport children in motor vehicles. With your written permission in the Special Instruction section above, sitters may accompany your child(ren) in hotel shuttles, taxi, or on Park City Transportation bus system.
- *The Clubhouse gives permission for the sitter to leave the primary babysitting location only in your presence, and by signing below, you agree to hold the sitter and The Clubhouse harmless in the event of any injuries, damages or incidents.
- *All scheduling of sitter services must be made through The Clubhouse. Employer (YOU) will be held accountable for full payment of amount due plus an additional \$50 if scheduling is done between Employer and sitter without notifying The Clubhouse. If a Sitter referred to Employer is employed without the knowledge and concurrence of The Clubhouse, Employer will be liable for the full placement fee normally charged for such placement in addition to a \$50 fee.
- *The Clubhouse is a sitter referral service. The Clubhouse does not guarantee he Employer will be satisfied with Sitter or Sitter's performance. Under no circumstances shall The Clubhouse or its representatives be held liable to Employer by reason of any claim Employer has against Sitter, or by reason of any acts of omissions of Sitter hired by Employer. Employer agrees to indemnify The Clubhouse and hold it and its representatives harmless from any and all costs or expenses (including, without limitation, reasonable attorney fees) arising out of any claim against The Clubhouse or its representatives relating in any way to Sitter's employment.
